A National Leader with over 48 years contribution to nation building and having the distinction of being the Chief of Army Staff and later Governor of Arunachal Pradesh. He is a distinguished international personality and a public speaker with vast experience. He has a strategic perspective on foreign policy and defence relations with neighbouring countries. He has a global insight and vision for strategic defence relations, indigenisation of defence industry on PPP mode and modernisation of Defence Forces. His perspective and knowledge is a valued national asset which can used to steer long term national defence and security policy. He is luminary of great distinction and by his exemplary vision, leadership and sagacity, he can contribute for development of corporate governance, CSR and steer international and national growth and excellence agenda for any global corporation

The General became the 22nd Chief of Army Staff and commanded the second largest Army of the world from 31 Jan 2005 - 30 Sept 2007. During his tenure General JJ Singh, refined operational planning by co-opting the battle winning role of revolution in military affairs and provided focussed direction based on the 'Doctrine of the Indian Army' having earlier been its architect, He has handled an army of 1.2 million soldiers and managed defence assets of many billion rupees as the Army Chief. He has also had the privilege of being the first Indian Defence Attaché in Algeria. The General served as Governor of the State of Arunachal Pradesh from 2008-2013. He was proactively instrumental in implementation of the Prime Minister's development package of Rs.20,000 crores for development of state in major infrastructural projects related to road, rail, air connectivity and power.



Food Insecurity Issues in Children and Women in North India with special reference to the National Food Security Act, 2013

The Innovation Project, SGGSCC-304, entitled, Food Insecurity Issues in Children and Women in North India with special reference to the National Food Security Act, 2013 is aimed at tracking malnourishment especially in pregnant, nursing women, infants & children in few states of North India. The research aims to investigate food insecurity at the individual level particularly amongst the marginal subgroups including women and children with special reference to food security policies and NFSA guaranteeing entitlements. Women and Children are most food-insecure subgroups of the population. Government should ensure a healthy & productive life to every citizen including these vulnerable sections. Nutrition is a major driver for development of children (future citizens)- cannot be a stand-alone agenda & separated from health & social progress. hinders the setting- up and growth of these business models. This also acts as an obstruction in carrying out relevant and meaningful research work in these areas.

An effective solution to the problem of waste in India, particularly in urban areas, lie in the use of modern technology in the form of waste converter machines; and creating awareness among people for proper waste segregation and disposal.

OBJECTIVES OF THE STUDY includes identifying and specifying the extent of major problems of social nature in India like Food, health, housing, sanitation, Hygiene, Education, Waste collection and disposal, provision of civic facilities etc.; reviewing the progress of various measures initiated by Government, Non-profit organisations, NGOs, and the corporate efforts through its CSR initiatives in dealing with these social problems; finding the examples of various Social business operating in India; gathering various examples from other countries, of Social business successfully catering to their social problems; examining how far these patterns of successful social business can be applied in the context of social problems in India; identifying the various measures that should be taken to promote social business in India.

The Innovation Team is collecting evidences of genderspecific malnutrition levels & household-based food insecurity confronting women in Delhi and Rajasthan to suggest promotive and preventive healthcare amongst them. The team has the objective of tracking food insecurity through Food for Education Programme or the Mid-day Meals Scheme amongst children living in rural areas and urban slums and assessing the Learning & Health Outcomes of MDM through Econometric Modelling sing Panel Data. On the basis of collected primary data and existing literature and secondary data available from varied sources pertaining to gender and children issues, corrective steps would be addressed.

(Report by the Academic Affairs Committee (AAC)

The NATIONAL ASSESSMENT AND ACCREDITATION COUNCIL (NAAC) is an autonomous body established by the University Grants Commission (UGC) of India to assess and accredit institutions of higher education in the country. It is an outcome of the recommendations of the National Policy in Education (1986) which laid special emphasis on upholding the quality of higher education in India.

The Academic Affairs Committee (AAC) and the Internal Quality Assurance Committee (IQAC) were entrusted with the responsibility of steering the NAAC accreditation exercise on behalf of the college.

As the first step in the accreditation process, the college was required to submit a Self-Study Report (SSR) containing the status on the seven 'Evaluation Criteria' and 'Departmental Evaluative Reports' mandated by the NAAC. The report prepared per NAAC guidelines and was organized into three parts viz. Profile of the Institution, Criterion-wise Inputs, and Evaluative Report on various departments.

The preparation of the SSR was a wonderful voyage of discovery for the institution's leadership and staff. It provided valuable insights into various aspects of college administration, infrastructure, curricula, teaching methods, academic research and teacher-student relationship in terms of our strengths, weaknesses, opportunities and challenges. The following paragraphs provide a brief summary of the findings on the various criteria mandated by the NAAC.

The institution encourages improvisation in teaching pedagogies and has put in place feedback mechanisms to optimize curriculum delivery and maintain quality of learning. The Academic Affairs Committee of the college ensures meticulous planning and scheduling of academic and extra-curricular activities; accountability of the faculty; transparency in student evaluation; high quality classrooms and lab infrastructure and open access to information on research opportunities and faculty development programs. Curriculum enrichment is facilitated through Seminars, Conventions, Workshops, Guest Lecturers, Special Lecturers, Employability Skills Workshops, Summer Internships, Case Studies, etc. and plethora of activities organized by various

student societies and clubs on topics of professional, cultural and social importance. Societies like National Cadet Corps (NCC), National Service Scheme (NSS), The Enabling Unit, Equal Opportunity Cell, International Cell, Enactus, etc. instill a sense of social responsibility and community development.

An active Placement Cell, a well-knit alumni network, plethora of industry linkage events, research projects and special add-on courses (e.g. Tally, SPSS, etc.) and ICT workshops help students become industry-ready professionals. We strongly believe that research is the prime source of knowledge and innovation. Knowledge generated is the basis of excellence and sustainable development of the institution. The College continually strives to inculcate the spirit of research and scientific temper in the young minds as a matter of routine through curriculum-based attempts and research projects.

For an educational institution, students are the most critical stakeholders. They are the end products of all inputs and the institution's contribution to the society, country and the world. The academic training, soft skills and values invested in them are significant factors in an institution's success. A student's progression through the college years therefore needs close monitoring.

The College strives to contribute towards the task of building high sense of social responsibility and emphasize on human values in the students to make them successful, both in academics and otherwise. The students imbibe the values of good citizenship and concern for the society through the various activities of the societies/clubs of the college viz. the National Service Scheme (NSS), the Rotaract Club, Enactus, Soch E-cell, Disha, Jaagriti, Sambhavana, etc. As part of the Go-Green initiative, solar lights have been installed for lighting the pathways. A garbage treatment plant is proposed to be built to process organic waste and a sewage treatment plant is also in pipeline.



Rise in the total cumulative income of Entrepreneurs in Project Shakti has been Rs. 50,00,000 quoted as 'Naukari.com for low income groups' by DU Beat-7,46,524 media impressions

Project Shuchita was initiated in August'15. It aims at solving the problems of sanitation, cleanliness and menstrual hygiene in the sub-hubs of Delhi with the motto of Greener, cleaner and more aware environment. The project successfully collaborated with Sulabh Sanitation Works. Permissions from Narela Industrial Estate Association (NIES) and the Delhi Police were taken to acquire land to construct 2 pit toilet. Campaigns to spread awareness about menstrual hygiene were undertaken and over 500 sanitary pads were distributed in rural and tribal areas. The Volunteers Program was conducted for our initiative "Book A Plant" in which more than 1200 potted plants were sold throughout the Delhi NCR region within 20 days of operation of the initiative.

Project Amber is an initiative towards economic empowerment of domestically victimized women in our country by inculcating entrepreneurial skills in them and
